General Safeguarding Statement - Footprints Conductive Education Centre

Footprints Conductive Education Centre (FCEC for future reference in this document) will take all practical and reasonable steps (precautions) to:

For all FCEC the Designated Safeguarding Officers are Stephen Frew Manager, Erika Juhasz Head of Service Carole Luckwell-Trustee Advisor.

This statement applies to anyone working on behalf of FCEC, including senior managers and the board of trustees, paid employees, volunteers, seasonal workers, learners, service users, visitors, and the public.

FCEC recognise the potential impact of our activities on employees, young people, and members of the public.

It is the responsibility of the Board of Trustees of FCEC to monitor the implementation of the FCEC safeguarding policies and the company's overall safeguarding performance by receiving safeguarding reports from the Designated Safeguarding Officer.


